




# 2024 Contribution Results 2024 All Yea

The overwhelming success of the GOAL program speaks volumes about its importance. Each year, the demand for tax credits exceeds the overall cap of \$120 million on the first business day of the year, resulting in proration of all applications. In 2024, applicants received only 63% of their requested amount due to oversubscription.



Since inception, GOAL has awarded **\$318 million** in scholarships to more than 28,200 deserving Georgia students.



#### **Corporate Funds & Giving Opportunities**

### A Note for Business Owners & Tax Advisors

GOAL wishes to thank Georgia business owners for the impact they are having in improving Georgia K-12 education through this program.

Favorable state and federal tax laws and regulations are allowing pass-through businesses to invest in Georgia K-12 education while achieving significant tax benefits.

Depending on how you will pay your 2025 taxes, there are two opportunities for passthrough businesses to make a substantial impact – and achieve tax benefits – through GOAL.

#### 1. Electing Pass-Through Method

GOAL tax credit is claimed at the entity level, under the name and FEIN of the pass-through business. Payment qualifies for state income tax credit and federal income tax deduction.

Tax Filing Status	Tax Credit Limit
Pass-Through electing to pay Georgia state income taxes at the entity level (HB 149)	75% of annual tax liability

#### 2. Individual Pass-Through Owner Method

GOAL tax credit is claimed at the individual level, under the name(s) and SSN(s) of the pass-through business owner (and spouse, if applicable).

Payment qualifies for state income tax credit and potential (presence of business purpose) federal income tax deduction.

Tax Filing Status	Tax Credit Limit
Pass-Through Owner (not making HB 149 election)	\$25,000

## Sign Up for a 2025 Tax Credit

#### Take Control of Your Taxes & Support Student Scholarships

Through Georgia GOAL, you can make a difference by contributing funds that directly support deserving students' access to an exceptional educational environment, and you will receive a 100% state income tax credit in exchange for your contribution.

#### **Tax Credit Limits Based on Filing Status**

Tax Filing Status	Tax Credit Limit
Single Filer	\$2,500
Married Separate Filer	\$2,500
Married Joint Filer	\$5,000
Individual Pass-Through Owner	\$25,000
C Corp, Trust, or Electing Pass-Through	75% of annual tax liability

In order to obtain a GOAL tax credit, you must apply before the end of 2024. Credits will be oversubscribed and prorated again this year.

#### How to Secure a 100% Georgia Income Tax Credit



#### June-December 2024

Complete and submit the 2025 GOAL Tax Credit application on the GOAL website at goalscholarship.org

#### Mid-March 2025

Pay GOAL by credit card, ACH transfer, or check within 60 days of your DOR approval notification



Take the Credit

#### January 2025

GOAL submits your application to Georgia DOR and notifies you of your approved tax credit amount and payment deadline

### When you file your 2025 tax return in 2026
